EMPLOYMENT HIGHLIGHTS

In this role I give workshops, seminars, and programs that are designed to meet customer needs. I also do comedy shows that have a stress reduction or educational focus.

MISSOURI DEPARTMENT OF MENTAL HEALTH, OFFICE OF DEAF AND LINGUISTIC SUPPORT SERVICES

As Director, I was responsible for assuring that people with hearing loss or limited English proficiency have access to appropriate mental health care. Working with three service divisions within the Department (Comprehensive Psychological Services, Alcohol and Drug Abuse, and Mental Retardation and Developmental Disabilities) the Office of Deaf and Linguistic Support Services provides program development, training, consultation and technical support to facilities and service providers working with consumers who have hearing loss or limited English proficiency. In 1994, I was nominated Central Office Employee of the Year.

COMMISSION ON COURTS AND THE DISABLED

This Commission, appointed by the Chief Justice of the Missouri Supreme Court, was charged with reviewing and enhancing access by the disabled to the Missouri courts.

BREAKOUT VI: NATIONAL CONFERENCE ON PSYCHOSOCIAL REHABILITATION AND DEAFNESS

I was the general conference chair of this large national conference, held in St. Louis, Missouri, May 11 - 13, 2000.

MISSOURI STATE BOARD OF CERTIFICATION OF INTERPRETERS

In this Governor appointed position I had the responsibility of helping develop the certification process for Sign Language Interpreters in the State of Missouri.

MISSOURI STATE TASK FORCE ON DEAF EDUCATION

This task force, appointed by the Department of Elementary and Secondary Education, studied the status of Deaf Education in the state of Missouri and made numerous recommendations to address serious deficiencies in how deaf children are being educated. I was one of the principal authors of the final report.

NEW MEXICO COMMISSION FOR THE DEAF AND HARD OF HEARING

I was one of the leaders in the effort to establish this Commission in New Mexico, drafting the enabling legislation and guiding it through the State Legislature. The Commission was formally established in July of 1991 and I was elected to be the first Chairman.

OLATHE DISABLED PERSON ADVISORY BOARD

As Chairman of this Board, I was responsible for overseeing the work of the Special Services office. The Board was instrumental in the establishment and expansion of the Olathe City Relay, which served about 800 deaf consumers in this town of 50,000 people. All city offices were made accessible by TTY and modified for accessibility by people who are blind or mobility impaired. City parks and playgrounds were made accessible to wheelchair users. A running track modified for blind consumers was established.

KANSAS STATE MENTAL HEALTH TASK FORCE

This Task Force was established by the Governor to examine the needs of the Deaf and Hard of Hearing citizens of Kansas. We identified broad areas of need and conducted a census of Deaf people in penal institutions and state hospitals, where they were poorly served. As a result of this work, a separate division of Social Services was funded and a number of improperly imprisoned Deaf people were given mental health services that allowed them to return to society as contributing members.

TEMPLE DEAF COLLEGE

While I was on the College staff, I traveled all across the country and spoke in more than 300 different churches before audiences ranging in size from 15 to 25,000 people. I learned to communicate effectively with people from all walks of life. I wrote, produced and directed *One Day Too Late,* a play that was performed more than 100 times across the country during the period 1977 through 1979.
